RLC WORKS WITH THIS FRITO LAYS FACTORY AS NEEDED, PICKING UP ON AVERAGE THOUSANDS OF POUNDS OF CASES OF SNACKS THAT WOULD OTHERWISE HAVE BEEN THROWN OUT. RLC DELIVERS THIS TO MANY FOOD BANKS, HOMELESS SHELTERS, AND SOUP KITCHENS AROUND THE PORTLAND AREA. MORE THAN 1,000 PEOPLE BENEFIT FROM THE FOOD DONATED BY FRITOS LAYS ON EACH DELIVERY.
